

## Towergate Home & Protect Select - Policy Summary

Some important facts about your Towergate Home & Protect Select insurance are summarised below. This policy summary does not contain the full terms and conditions of the contract. Please read the full policy document to make sure you understand the cover it provides.

### Insurer

Other than noted immediately below the insurance for this policy is provided by a consortium of insurers comprising AXA Insurance UK plc, Royal & Sun Alliance Insurance Group plc, Equity Red Star and Allianz Insurance plc. Details of their proportionate shares are shown on the policy schedule

The Family Legal Protection, Identity Theft Protection and Emergency Home Assistance Cover of this policy are underwritten by DAS Legal Expenses Insurance Company Limited, Registered Office: DAS House, Quay Side, Temple Back, Bristol, BS1 6NH. DAS Legal Expenses Insurance Company Limited are authorised and regulated by the Financial Services Authority.

### Type of insurance

The Towergate Home & Protect Select policy provides cover for the Buildings and Property Owners Liability and/or Contents of your home, Occupiers Liability and Valuables and Personal Effects as selected by you. Family Legal Protection, Identity Theft Protection and Emergency Home Assistance cover is provided where selected.

### Duration

The Towergate Home & Protect Select insurance policy will remain in force for a period of 12 months from the date of commencement, or as otherwise shown on your policy schedule. You may need to review and update the cover periodically to ensure it remains adequate.

### Cancellation rights

We hope that you are happy with the cover this policy provides. However, you have the right to cancel it within 14 days of inception or renewal or receipt of policy or renewal documentation, whichever is the later, without giving any reasons. If that happens, your premium will be refunded to you, after deduction of a charge for the cover provided from the beginning of the contract to the date of cancellation, and in the event that a claim has not been made that would be considered as having completed the contract.

### Making a claim

### How to make a complaint

You will be assigned an identity theft caseworker who will discuss with you a personal action plan to help regain your identity. You can claim for the reasonable costs you incur to recover your credit status as agreed in the action plan, such as postage and communication costs.</p> <p><b>Identity Theft Legal Protection</b> – If legal action is necessary to reinstate your identity or defend any case brought against you by traders, the policy will cover you for legal costs of an appointed representative.
